Graduate/Masters/Doctoral student collegiate members shall have Graduate/Masters/ Doctoral standing in an institution offering coursework in the field of education; and have the intent to continue academically and professionally in the field of education.  When a collegiate member starts her career as a paid educator, she will pay active member dues and become an active member. If a collegiate member does not pursue a career as an educator, her membership will expire upon graduation or withdrawal from the education degree program.	X	X

Article IV.C.2 (PA 63)	New members shall become members when dues are paid. New members who join between July 1 and December 31 shall pay full international dues for current fiscal year. New members who join between January 1 and March 31 shall pay half dues. New members joining between April 1 and June 30 shall pay full international dues for the ensuing year. Reinstated members shall pay full annual dues whenever reinstated. Chapter and state organization dues may be prorated as the chapter/state organization determines.	X	X

Article IV.C.3 (PA 64)	Immediately thereafter, the state organization portion of the dues shall be sent to the state organization treasurer and the international portion to the International Headquarters	х	X
Article IV.F.3.f (PA 62)	The principal of the Society and state organization permanent funds shall be used for the following: (1) purchasing induction paraphernalia; (2) purchasing articles and equipment of a permanent nature; (3) technology-related upgrades and licenses for computer software; (4) renting office space; (5) constructing a headquarters building; and (6) furnishing a headquarters building. Article VIII.B.6.b (PA 92)	Leadership Development Committee* – appointed b. The committee shall be responsible for leadership development at the international level. (2) The location and time of the training shall be determined by the committee with input from the Administrative Board and professional staff. (3) A stipend, as approved by the Administrative Board, shall be allocated to each state organization to offset expenses in connection with training. (4) The committee shares responsibility with the state organizations for leadership development of state organization and chapter leaders.	X
